**DOMESTIC VIOLENCE AWARENESS MARCH & BRUNCH**  
***HOSTED BY THE HUSH HOUSE FOUNDATION***

On October 4, 2025, The HUSH House Foundation proudly hosted its inaugural Domestic Violence Awareness March and Brunch in Plainfield, New Jersey. The event marked the official introduction of the organization to the community and brought together residents, city leaders, youth groups, law enforcement, businesses, and advocates in a unified stand against domestic violence.

**EVENT OVERVIEW**

The march was organized and led by The HUSH House Foundation, bringing visibility to the ongoing fight against domestic violence and creating space for healing and hope. The event began with a community march through the streets of Plainfield and concluded with an empowering brunch program that celebrated resilience, awareness, and collective action.

**COMMUNITY ENGAGEMENT AND SUPPORT**

The event was a powerful demonstration of collaboration across the city. The Plainfield Marching Band, Cheerleaders, Majorettes, and members of the Plainfield Titans Cheerleaders joined the march, bringing energy and youth leadership to the cause. The American Dance Studio of Edison also delivered a heartfelt performance during the brunch.

Local leadership showed strong support for the mission. Councilman Robert Graham participated in the march, while Councilwoman Julianne Cherry offered a powerful message during the brunch program. Azim Gray, Finance & Operations for the Plainfield Board of Education, also joined us and shared valuable insight and encouragement. Reverend Selina D. Carter served as keynote speaker, delivering an inspiring address on the importance of breaking cycles of abuse and building pathways to healing.

Even in her absence, United States Congresswoman Mikie Sherrill, Democratic nominee for Governor of New Jersey, extended her support to the mission by sending official certificates to honor seven survivors, a gesture that underscores the importance of continued advocacy and recognition for those impacted by domestic violence.

Law enforcement provided critical support throughout the day, with the Plainfield Police Department escorting the marchers, managing traffic, and securing the brunch venue for the duration of the event.
